- d. Nominating Committee-Addition of individuals from childcare center- Discussed having a provider named Chelsea joining the FCFC Committee. Christi will invite her to the next FCFC meeting to observe and see if she is interested in joining.
- e. ECCC Update-Christi Reveal-ECCC just met this morning and planned a family dance event on December 6th at Eagles Point; ECCC is working on a flier for the event and will get that out soon. The last time this event was held was February 2020 so the group is hopeful it will have a great turn out. ECCC is seeking donation assistance in the form of financial or food options. Christi will also send out the updated ECCC flier that can be distributed to families or those wondering what services are available. HS has openings for preschool and Christi is happy to talk with families or do outreach.
- f. OCTF-Whitney Loftis/Ashley Hausmann-The next OCTF meeting is on Wednesday next week, taking proposals for funding to serve our region; Miami University has a large Big Brothers/Big Sisters and legal aid for families are the current funded projects in this region. In the past there has been funding for parenting classes but these are not typically held in locations that Preble County families can access. Several group members shared that reporting and funding through OCTF is really challenging and deter many agencies from participating.

VI. GRANTEES UPDATES

a. Help Me Grow-Ashley Hausmann-Made an employment offer to a new DS (Developmental Specialist) and they will be starting on November 14th, however it will take time for their certification and training, and should begin to take new families in the next 4-6 months. The Service Coordinator currently has a caseload of 45 and after 50 families, Ashley steps in to help with overflow. In the Spring Ashley is planning to work

- with the intake and outreach team to conduct Pediatrician visits to remind them about EI services and how services can be provided. Few reminders that Help Me Grow Early Intervention is a free, voluntary program, and serves all children 0-3 who have a delay or suspected delay in development. There is no waitlist for services. Christi requested that Ashley let her know when she does outreach because she would like to tag along to talk about preschool options.
- b. Help Me Grow Home Visiting-Emily White- The Home Visiting program is a parent support and education program with a focus on curriculum and resource support for families. We currently have 15 families enrolled and there are open spaces available for referrals. Home Visiting works closely with DODD and families can have both services. Council members were provided with a bag of items that included free promos and literature on how to make a referral.
- c. Wraparound-Becky Sorrell/Cara Ditton-Cara provided a written report for the meeting today, attendees reviewed it. OASCIS database is in production which will help with the streamlining of services for families and providers. Cara completed her re-certification in CANS on 9/22/22 and completed QRTP CANS training on 10/17/22. Care recently presented at Gebhart Counseling Center and is working to schedule a presentation with South Community. Cara shared her caseload numbers and a fiscal update on 1 child where the financial coverage was a concern. Cara stated MSY has decided to cover that child for an additional 90 days. Discussion about referrals from attendees and Cara suggested just calling her with referrals and she will sort out the CANS assessments and work with Ohio Rise.
- d. OhioRise-Amy Raynes-See above for additional information. Ohio Rise does attend JFS meetings and makes an effort to assist families by bringing new ideas to the table, however the lack of community resources is posing a challenge.

VII. AGENCY UPDATES-

- a. Any Preble County Agency may give updates;
 - Samaritan Behavioral- MRSS stabilization service lead therapist has resigned; looking to rehire for the position, \$5,000 sign on bonus to try and fill the position quickly. Looking for a Masters clinician and someone who wants to work with complex family systems. Lots of supervision is provided; On-demand and stabilization will be a secondary work load and they will prioritize those families with immediate safety concerns.
 - Abolitican Ohio-An organization with a focus Human Trafficking shared that numbers continue to rise; they are using missing children's posters and ref flag tip sheet to bring awareness to community members nad organizations. Talked about some myths related to Human Trafficking. Oftentimes, there is a long "grooming period" with individuals involved in trafficking situations so it's imperative that educators and the community as a whole is aware of the signs. Remember to pay attention to drastic changes in behaviors, marks, dissociation from school or family and new items such as cell phones and clothes that Traffickers could be providing. College students are especially at risk, as well as small children. The Abolition and YWCA offered to do training for agencies who need or would benefit from further education.
- b. Amy Carles-Energy costs are going up and anticipation of them continuing to climb for a whole; Will send out an email with all of the resource handouts
